# Experts to Debate Future of Centralized Regulatory Review in Obama Era at CPR Symposium, May 22

(Washington) -- The Center for Progressive Reform (CPR) will hold a symposium in Washington on Friday, May 22, gathering experts from across the spectrum to debate the future of regulatory review policy. The event, *Reforming OIRA: The Future of Regulatory Review*, aims to contribute to the discussion on the Obama Administration's upcoming new executive order on regulatory review.

The symposium will gather many of the most prominent advocates and critics of the existing system of centralized review of individual rules using traditional cost-benefit analysis. Through a series of four panel-led discussions, the symposium will examine and critique this system and evaluate possible options for reform. The event is open to the press.
